DISCIPLINE SPECIFIC SELECTION CRITERIA

Para-cycling Track

2020 UCI Para-cycling Track World Championships

30 January – 2 February 2020 | Milton, Canada

1 GENERAL

- 1.1. **Athletes** will be required to earn Para-cycling Track World Championships Team selection in accordance with clause 1 of the *Cycling Australia Selection Policy and Appeals Process for UCI World Championships*, and this discipline specific document of the Cycling Australia (CA) selection criteria.
- 1.2. **Objectives:** see clause 1 of the *Cycling Australia Selection Policy and Appeals Process for UCI World Championships*.
- 1.3. **Performance Time Period:** 14 March 2019 - 3 November 2019
- 1.4. **Team Size:** refer to clause 3.3 of the *Cycling Australia Selection Policy and Appeals Process for UCI World Championships*.

2 Para Track Specific Eligibility

- 2.1 To be eligible for the final team athletes will be required to:
 - 2.1.1 fulfil the general eligibility criteria requirements as stipulated in the *Cycling Australia Selection Policy and Appeals Process for UCI World Championships*, clause 2.1;
 - 2.1.2 have a minimum of a National Para-cycling Classification;
 - 2.1.3 compete in the 2020 Australian Para-cycling Track National Championships that immediately precede the 2020 UCI Para-cycling Track World Championships, unless granted extenuating circumstances as per clause 4 of the *Cycling Australia Selection Policy and Appeals Process for UCI World Championships*.

3 SELECTION CRITERIA

- 3.1 Consideration of athletes for selection to the Para-cycling Track World Championships Team may be based upon achieving:
- i) performances standards at clause 4 of this document; and/or
 - ii) accordance with the general performance selection criteria at clause 2.2 of the *Cycling Australia Selection Policy and Appeals Process for UCI World Championships*, where the National Selection Panel may use absolute discretion.

4 PERFORMANCE STANDARDS

- 4.1 The National Selection Panel may consider the performance outcomes and standards of eligible athletes who:
- 4.1.1 are the reigning 2019 Para-cycling Track World Champion; or
 - 4.1.2 achieve a world record during the performance time period in a track event and classification that will be held at the 2020 Para-cycling Track World Championships; or
 - 4.1.3 during the performance time period, achieve at the 2020 Australian Para-cycling Track National Championships or UCI approved event, the performance standard (times) specified in Attachment A, specific to the athlete's nominated event and classification (C1 to C5 and Tandem (B)).
- 4.2 **Pilots (Tandems)**
- 4.2.1 for tandem teams, the recording of multiple performance standards as listed at clause 4.1 of this discipline specific document, may only be considered valid by the National Selection Panel where the same pilot and athlete pairing has recorded all performances;
 - 4.2.2 in the event that a tandem team requires a change in pilot (after attainment of one or more of the criteria listed in clause 4.1 of this discipline specific document) the final selection to the team may be at the National Selection Panel's discretion and made pursuant to clause 1 of the *Cycling Australia Selection Policy and Appeals Process for UCI World Championships*.
- 4.3 Athletes who attain one or more of the selection criteria and performance standards listed above at clauses 3.1 and 4.1 of this discipline specific document, may be ranked in order of priority for consideration pursuant to the team objectives at clause 1, and the eligibility and selection criteria at clause 2 of the *Cycling Australia Selection Policy and Appeals Process for UCI World Championships*.
- 4.4 Should more athletes satisfy the criteria than available UCI Nation Starting Quota places, or should the number of athletes nominated be less than the available UCI Nation Starting Quota places, the National Selection Panel may use absolute discretion to consider athletes according to some or all of the factors in clauses 3.1 and 4.1 of this discipline specific selection criteria and clause 2.2 of the *Cycling Australia Selection Policy and Appeals Process for UCI World Championships*.

5 SCHEDULE FOR PARA-CYCLING TRACK WORLD CHAMPIONSHIPS TEAM SELECTION

- Monday, 11 November 2019 (5PM AEST) – Deadline for submission of recorded performances for selection period
- Wednesday, 13 November 2019 (5PM AEST) – Final Para-cycling Track World Championships Team selection forwarded to Cycling Australia CEO for endorsement
- Monday, 18 November 2019 (5PM AEST) – Final Para-cycling Track World Championships Team announced by CA
- Wednesday, 20 November 2019 (5PM AEST) – Closing date for appeals against non-selection (*Cycling Australia Selection Policy and Appeals Process for UCI World Championships*, clause 7)
- Friday, 22 November 2019 - Day scheduled for appeal hearings, if required
